I am pleased that the outcome appears to demonstrate more balance and will more closely reflect the actual partisan make-up of the state than previous iterations. Dear Commissioners:

We represent individual voters of certain Missouri Senate districts that are overpopulated under the tentative redistricting plan you filed on February 23, 2012 (the "Plan"). Please accept this letter as our request for an immediate public hearing under article III, section 7 of the Missouri Constitution.

We note that the constitution requires that this Committee "shall" hold a public hearing within fifteen days after the filing of its tentative plan. We can find no public notice that such a hearing has been scheduled. A hearing is necessary in this case. Four hearings were held starting on Sunday, February 19, 2012, in rapid-fire succession. The public had little opportunity for notice or input. And the crucial time for providing input is now, after the public has become aware of the Commission's tentative proposal.

Further, it is our belief that the plan is constitutionally defective. While the population deviation between the most overpopulated and underpopulated county is (perhaps not coincidentally) just below 10%, the most severe deviations favor urban regions and discriminate against rural regions. This regional favoritism is an impermissible basis for population deviations and constitutes invidious discrimination in violation of the Fourteenth Amendment of the United States Constitution.

The plan's invidious discrimination against rural Missourians is further evident in the arbitrary reassignment of the seventh district designation to the urban core of Kansas City and the transfer of the urban core tenth district in Kansas City to a new rural district in eastern Missouri. This deprives the residents of the new eastern Missouri district of adequate



representation and of the right to timely elect a new resident senator, and further serves to artificially increase the representation of urban regions at the expense of rural regions. At the Commissioner's first hearing, Solicitor General Layton specifically warned the commissioners against such a move.

Finally, we understand that certain Commission members have already acknowledged the arbitrary nature of the Commission's moves. Additionally, certain Commission members, rather than inviting public comment and scrutiny, have actively worked to stifle public review of the plan. This further convinces us of the need for an open and public hearing.

We respectfully request that a hearing be convened in a convenient place no later than Wednesday, March 7. Please notify us immediately by phone, email, and letter of the time and place of the hearing.

The undersigned voters who reside in the proposed 10<sup>th</sup> Senatorial District wish to express to the Commission their dissatisfaction with Commission's complete disregard for our right of representation. By the illogical numbering scheme adopted by the commission the new 10<sup>th</sup> Senatorial District consisting of six counties in east central Missouri would be represented for two years by a sitting Senator from Kansas City who has no connection to our district. To cause this situation, the Commission moved the 7<sup>th</sup> Senatorial District from St. Louis County to the Kansas City area covering much of what is currently the 10<sup>th</sup> Senatorial District, and moved the 10<sup>th</sup> District to our area. This renumbering defies logic for many reasons:

1. The boundaries of the current 10<sup>th</sup> District are not changed substantially in the new plan so there is no reason to renumber the area as District 7 and move District 10 to rural Missouri.
2. The current Senator in the 10<sup>th</sup> District would continue to represent roughly the same area if that District remained the 10<sup>th</sup> District rather than being renumbered the 7<sup>th</sup> District. This representation would continue for two more years before an election allowing that Senator to represent many of the same constituents.
3. The current 7<sup>th</sup> District would be up for election in 2012. If that numbered District were moved to the six counties in the proposed District, those voters would be able to elect a Senator to represent them. As currently constructed, no sitting Senator lives in the six counties in the new proposed 10<sup>th</sup> District, depriving us any representation.
4. Being skeptical Missourians we have to wonder why a Kansas City Democrat would be assigned to represent a rural Missouri District in eastern central Missouri where every county in the new proposed District is currently represented by a Republican. Even if political affiliation is ignored, the interests of a metropolitan Kansas City Senator have little in common with the economic agricultural interests of the six counties in the proposed 10<sup>th</sup> District which essentially deprives them of a voice in their economic and political interests.

We ask the Commission to reverse the decision regarding the numbering of the Districts for the proposed 7<sup>th</sup> Senatorial District and the 10<sup>th</sup> Senatorial District to allow the members of Audrain, Callaway, Warren, Montgomery, Monroe and Lincoln to elect a Senator from our area to represent us.

Dear Representative Hesser,

The new redistricting map appears to be unconstitutional. It gives unfair advantage to urban regions over rural regions in the state. The map contains much lower populations in the urban districts. Therefore, it produces more senators from the urban areas. This regional advantage is discriminatory and not permissible under the U.S. Constitution. The following examples clearly illustrate the flaws in the new districts.

1). The population numbers in St. Louis City and County were changed enough to yield only one Republican Senator from the area in the near future rather than the present four. Without having vigorous Republican senate campaigns in St. Louis County, the needed 150,000 votes needed to win statewide elections for Republicans is lost. This map is clearly a Democrat's and a liberal's dream map and unfortunately the Republicans on the Commission gave away the store.

2) St. Louis, the economic engine of the state loses its influence in the senate with this most recent map. Not only did St. Louis City and County lose an entire senate district when they lost less than 1/4 of a senate district in population, they increased the likelihood of the representation soon being six Democrats to one Republican senator rather than the present four and four. Because the Republicans are in the majority and therefore set the agenda and direction of the legislature, St. Louis has even less influence having to depend on the minority party to represent them. The population decrease of 40,000 (less than 1/4 of a senate seat) did not necessitate the loss of a senate district.
