### 4.0 DESCRIPTION:

- A. **Scope:** Backfill two dangerous highwall areas, make property improvements, seed, fertilize, and mulch. Fill an end cut area and a pit with earthen fill from the site. Import large rock riprap fill to create a water impoundment area and install new road culverts. See SEC 011010 for full scope of work.
- B. Estimate: \$444,000 to \$542,000
- C. MBE/WBE/SDVE Goals: MBE 10.00% & WBE 5.00% SDVE 3.00%. **NOTE: Only MBE/WBE firms certified by a State of Missouri public entity as of the date of bid opening, or SDVE(s) meeting the requirements of Section 34.074, RSMo and 1 CSR 30-5.010, can be used to satisfy the MBE/WBE/SDVE participation goals for this project.**

- A. **Place/Time:** **11:00 AM; Wednesday, February 13, 2013;** From Rich Hill, take Rte A and turn west (RT). Go about 10 miles to Hwy V. Turn north (RT) on Hwy V and go 2.2 miles to CR 601. You'll see Independence Church and graveyard on the left. Turn onto CR 601 and go west for 1.7 miles. Cross the RR tracks where it intersects with another county road. Go north (RT) on CR 13007 for approx. 1 mile to the pre-bid location. Park vehicles along the shoulder of CR13007.
