General Information:

C110104001 through C110104007 are established for the purchase of carpet. The contracts are for carpet purchases for Executive Department state agencies throughout the State of Missouri. Furthermore, the contractors have agreed to extend pricing herein to Cooperative Agencies.

Preferred Use of Contract:

The contract shall be considered a preferred-use contract which means all state agencies should use the contract for the carpet on contract if needed. Even though the contract is considered a preferred-use contract, there will be rare situations where an agency may waive itself from using the contract so long as such determination is supportable and in the best interest of the State. Reasons for not using the contract shall include but shall not necessarily be limited to the following: offered carpet is not usable by the state agency; order delivery time is not meeting state agency's needs; specific item is out-of-stock for an unreasonable amount of time (to be determined by the state agency) without an acceptable substitute; specific item on contract is not what the state agency legitimately needs to meet its agency's public responsibilities; cost of the item exceeds historical and/or current market pricing and it would be unduly burdensome for the agency to pay the contract price.

Ordering:

The agency shall issue its own PGQ (Quick Price Agreement) order to the contractor on an as needed basis. The contractor must not ship until they are in receipt of a hard copy PGQ order.

Price:

The state shall not pay nor be liable for any other additional costs including but not limited to taxes, shipping charges, insurance, interest, penalties, termination payments, attorney fees, liquidated damages, etc.

Delivery Performance:

The contractor shall deliver products in accordance with the contracted delivery times stated herein to the state agency upon receipt of an authorized purchase order or P-card transaction notice. Delivery shall include unloading shipments at the state agency's dock or other designated unloading site as requested by the state agency. All deliveries shall be at ground level locations with one drop-off area per location. All orders must be shipped F.O.B. Destination, Freight Prepaid and Allowed. All orders received on the last day of the contract, must be shipped at the contract price. All deliveries must be coordinated with the state agency.

Warranty:

The standard manufacturer's warranty shall be provided to the state agency purchasing carpet off the contract at no additional cost. A properly executed manufacturer's warranty must be in writing and delivered with the carpet.

Substitutions:

The contractor shall not substitute any item(s) that has been awarded to the contractor without the prior written approval

of the Division of Purchasing and Materials Management. Any product substitution must be of equal or better functionality and of equal or lower pricing.

The state reserves the right to allow the contractor to substitute any new product/system offered by the contractor on all unshipped and future orders if capabilities and quality are equal to or greater than the product/system under contract and if prices are equal to or less than contract prices. The Division of Purchasing and Materials Management shall be the final authority as to acceptability.

Replacement of Damaged Product:

The contractor shall be responsible for replacing any item received in damaged condition at no cost to the State of Missouri. This includes all shipping costs for returning non-functional items to the contractor for replacement.

Used Carpet Disposal:

If acceptable to the contractor, the contractor shall pick-up used carpet tiles and/or broadloom carpet and dispose of the used carpet at no additional cost to the State of Missouri. Acceptable disposal methods shall include recycling, upcycling, downcycling and/or repurposing. Traditional practices, such as landfilling shall not be used for disposal. The contractor must comply with all applicable local, state and federal carpet hauling and disposal regulations.

The state agency should make every effort to recycle used carpet tiles and/or broadloom carpet when the opportunity arises. On every carpet purchase, the ordering agency is advised to communicate with the contractor the order is being placed with to see if carpet pick-up by the contractor would be available at no additional cost to the State of Missouri.

The used carpet disposal will be dependent on the brand and type of used carpet being replaced.
