## GENERAL CONTRACT INFORMATION

1. **Purpose:** To establish a statewide contract for the provision of SAS PC software versions 6, 7, and 8 and the maintenance support services for said software through Executive Information Systems (EIS), LLC.
2. **Contract Period:** The initial contract period is 2/23/01 through 2/28/02. Amendment # 009 added an additional five (5) one year renewal options where in no event shall price increases exceed 10% over the previous year's pricing. New overall contract expiration date is 4/30/2013.
3. **Pricing:** All prices are firm, fixed for the contract period. **Pricing shall be pursuant to the pricing file posted on the statewide notice site.** All pricing is for SETINIT licenses (fifty (50) year licenses).
  - ◆ Version 6 maintenance pricing is for existing customers needing maintenance for said version.
  - ◆ Version 7/8 maintenance is for existing customers with Unix bundled licenses (not version independent)
  - ◆ All the rest of the products are current offerings and are the latest release.
4. **Maintenance:** EIS shall provide maintenance services and technical support for all software stated herein, including ongoing telephone support, problem determination and resolution. Technical support shall be provided Monday through Friday, 8:00 a.m. to 5:00 p.m. CST, excluding state holidays. EIS agrees and understands that the State of Missouri reserves the right to cancel maintenance on any or all of the items with 30 days prior written notice.

EIS shall provide a "call back" response to agency personnel for maintenance/technical support calls within four (4) business hours after the agency places the call.
