INSTRUCTIONS AND INFORMATION



1. **PREFERRED USE:** Services are on an as needed, if needed basis. This is as a preferred use contract but shall not be construed as an exclusive arrangement. Preferred use means that any state agency requiring the services should use the established contract unless it is determined to be in the best interest of the State of Missouri for a state agency to obtain alternate services elsewhere.
2. **MULTIPLE CONTRACTS:** Multiple contracts exists for the temporary medical professional personnel classifications identified herein (refer to Temporary Professional Medical Services Personnel Classifications Contractors).
3. **QUOTE REQUIREMENTS:**
 - 3.1 Quote Request: In order to fulfill the state’s procurement obligation to make awards to the “lowest and best” contractor, the requesting entity should obtain quotes from a minimum of six of the awarded contractors for the particular temporary medical professional personnel classification needed. If fewer than six contracts are awarded, the requesting entity will request quotes from all contractors.
 - a. In requesting quotes from the contractors, the requesting entity will request quotes that will minimally include the following:
 - 1) The requesting entity’s name and address;
 - 2) The issue date of the quote request;
 - 3) The due date of the contractor’s quote response;
 - 4) The timeframe of the temporary professional medical services requested, including the temporary medical professional personnel classification needed, and the location where the temporary professional medical services are required; and



- 5) The requesting entity’s designated contact name, email address, or fax number for the contractor’s quote submission.
- b. Quote requests may be revised by the requesting entity; however, the requesting entity will be required to notify all contractors from which the requesting entity requested quotes.

3.2 Quote Response: The contractor shall only quote the specifically awarded temporary medical professional personnel classifications requested by the requesting entity, and the contractor shall only provide the awarded temporary professional medical services that have been approved by the requesting entity and the Division of Purchasing’s Notice of Contract Award.

- a. The contractor shall provide then-current pricing (the hourly pricing for the specific temporary medical professional personnel classification and a hiring fee, (if applicable; refer to Hiring Fee Information herein) in the contractor’s quote response to the requesting entity.
- b. The contractor shall respond to the requesting entity’s quote requests in writing within a timely and efficient manner. If the contractor does not submit a quote response by the quote due date, the requesting entity may consider the contractor’s absence of a response as a “no bid” if the requesting entity needs to move forward with awarding services. The requesting entity shall document each instance of the contractor’s inability to provide services. Repeated “no bids” or a contractor’s repetitive inability to provide services without approved justification by the requested entity may be considered as the contractor’s lack of desire to continue participation under the contract.
- c. In the event none of the awarded contractors can provide the requested services, the requesting entity may obtain the needed services from another source.

3.3 Quote Evaluation: For each quote response obtained, the requesting entity shall perform a cost analysis based upon the quoted prices. Cost points for each quote received will be evaluated based on a 200-point evaluation scale by the entity requesting the services using the formula specified below. The requesting entity will confirm that the contractor’s quote response will meet the requesting entity’s minimum requirements, as stated in the quote request from the entity requesting the services.

$$\text{Lowest Responsive Vendor's Price} \times 200 = \text{Cost evaluation points}$$



Compared Vendor's Price

- a. During the evaluation of quote responses, the state agency reserves the right to request clarification of the contractor's intent regarding the contractor's quote.
- b. Quote requirements may be revised by the state agency via an amendment to the quote request prior to the quote due date, but the state agency may not conduct competitive negotiations during the evaluation of the quote or after award of the quote. In the event all quote responses fail to meet the requirements of the quote request, the state agency shall cancel the request for quote and if still desired, issue a new request for quote with revised specifications.

3.4 Approval and Award of Quote: For each quote response obtained from a contractor, the requesting entity shall total (1) the cost points derived from the cost analysis, and (2) any bonus points for Organizations for the Blind and Sheltered Workshop Participation and Missouri Service-Disabled Veteran Business Enterprise (SDVE) Participation (refer to Bonus Point Information herein). The contractor with the highest total combined points shall be considered the "lowest and best" quote response and shall be awarded the specific request for temporary medical professional personnel. However, the requesting entity shall have the right to reject all quote responses and not make an award. The bonus points for Organizations for the Blind and Sheltered Workshop Participation and SDVE participation shall be as specified in the contractor's awarded proposal submitted in response to RFPS30034902201108.

- a. The requesting entity will document their evaluation justification regarding their award determination of the "lowest and best" quote response at the time the quote is awarded.
- b. The requesting entity should inform all responding contractors of the outcome of the award. Acceptance of the quote response, unless otherwise specified, is not authorization to proceed through issuance of a purchase order or specific written authorization to proceed.
- c. In order to fulfill the requesting entity's needs, the requesting entity may make multiple awards per request.

4. **SCOPE OF WORK**: Due to the large amount of information included in the contract's Scope of Work, the information is not included in the Statewide Contract Notification. The

5. **CONTRACT MANAGEMENT:**
