4.0 DESCRIPTION:

- A. Scope: The project includes the completion of remediation activities on a former lead mine area. Activities include clearing of trees, excavation, grading and hauling of contaminated tailings and soil, construction of a pond, grading and hauling of clean borrow soil, hauling and placement of rock, rehabilitation of an old existing dam's concrete spillway and headwalls; and seeding, fertilizing and mulching of all work areas in accordance with the plans and specifications.
- B. Estimate: \$570,000.00 to \$775,000.00
- C. 8.0 GENERAL INFORMATION:

- A. The State reserves the right to reject any and all bids and to waive all informalities in bids. No bid may be withdrawn for a period of 20 working days subsequent to the specified bid opening time. The contractor shall pay not less than the prevailing hourly rate of wages for work of a similar character in the locality in which the work is performed, as determined by the Missouri Department of Labor and Industrial Relations and as set out in the detailed plans and specifications.

Directions to Pre-bid site from Potosi, MO:

Go East 14.5 mi on MO-8, turn left onto Hwy-P and continue 0.2 mi.

Take first left onto Landfill Rd; continue 0.3 mi until you see *Owl Creek Dam* site entrance on West (left) side of Rd; across from transfer station for the St. Francois County Landfill (SFCEC, 200 Landfill Rd).

ALTERNATE (BAD WEATHER) Pre-Bid location will be at the Missouri Mines State Historic Site Shop Bldg. Directions are as follows:

From Park Hills / MO-8 go SW on W Main St, turn right S onto Flat River Dr and continue over Hwy-32 where the road changes name to Sports Complex Rd / Federal Mill Rd, continue on Sports Complex Rd until you enter gate of Missouri Mines State Historic Site. Go straight ahead on gravel drive and past sign, where gravel drive curves to right / downhill between old bldgs. towards the Shop Bldg. (Note: Use Google Map to search for Missouri Mines State Historic Site, you will see SHS Shop Bldg.)
