Warranty: Equipment furnished under these contracts is warranted for a minimum of one year after receipt of equipment or by the most favorable commercial warranty offered by the contractor given to any customer for such goods or services. The contractor's equipment sold under this contract comes with a standard 12-month warranty. The end users may purchase an extended warranty services agreement at the dealer's standard extended warranty service rate agreed upon by the end users and contractor's local dealer, prior to purchase of the new equipment. Any extended warranty service agreements shall be done as an off contract purchase as such services are not part of the contracts identified herein.

Purchase Orders: Under the contracts, State of Missouri agencies, political subdivisions or governmental entities specified by the State of Missouri must contact their "local preferred dealer" listed herein for the respective contractor being utilized. The agencies end users shall contact only the dealer that is located in your vicinity for the purchase of equipment. It shall be noted that no services are included under this contract. The contractor shall not begin work without a valid Purchase Order.

Buy American: In accordance with the Domestic Product Procurement Act (hereinafter referred to as the Buy American Act) sections 34.350 to 34.359, RSMo, any goods purchased or leased by any public agency shall be manufactured or produced in the United States. If the equipment does not qualify for the Buy American Preference, the contractor's price(s) is increased by 10% in the evaluation for those items not eligible for the Buy American Preference. The following table indicates which equipment for each contractor does not qualify for the Buy American Preference and, therefore, for evaluation the prices for the construction equipment shall by increased by 10%.
