- 1. The Office of Administration, Division of Purchasing established the contract for Statewide Recycling Services for the Office of Administration, Division of General Services (GS), State Recycling Program.
- 2. The contractor shall either provide the services directly or shall provide a person/personnel who must comply with the requirements stated in the contract.
- 3. The contractor shall provide recycling services for recyclable materials on an as needed, if needed basis, for state agency offices and buildings located in Cole County and Jefferson City, Missouri.
- 4. **PREFERRED USE:** The contractor shall provide the services on an as needed, if needed basis. The State of Missouri does not guarantee any usage of the contract whatsoever. The contractor shall understand and agree that the contract shall be construed as a preferred use contract but shall not be construed as an exclusive arrangement. Preferred use means that any state agency needing the services should use the established contract unless it is determined to be in the best interest of the State of Missouri for a state agency to obtain alternate services elsewhere
- 5. SCOPE OF WORK: Due to the large amount of information included in the contract's Scope of Work, the information is not included in the Statewide Contract Notification.
